## **Report Backs**

Al Smith Dinner. Thursday, 10/17 at Hilton Hotel, 54th St/6th Ave at 6:30 pm.

Jody reported. Annual dinner honoring first Catholic governor of New York State. Attendance did not appear to be politically based. Our issue: Catholic churches in NYC, led by Cardinal Dolan, are not open as sanctuaries for immigrants. RAR had sent Cardinal Dolan a letter, which was passed out to those entering. Others held signs and banners. Many people entering seemed not to know about Dolan's stance and appeared interested to learn. We were there for 2 1/2 hours, until 7:30.

Jamie reported. Newt Gingrich was to be their speaker.

This event had not been posted on Facebook as right wing follows our planning for actions on Facebook. It was pouring rain, but still, perhaps 15 hardy members of RAR were there with appropriate, if wet, signage. As Metropolitan Republican Club has just one door, all those entering had to walk right past us. A policewoman pulled up, checked with Jamie that we knew the rules, and, satisfied that we did, returned to her car, rolled up her window, and remained

there. One Trump supporter did arrive with a banner, but rolled it up shortly and went inside. The presumption was that our number, however small, was still intimidating. The entertainment site TMZ came, rather inexplicably. Had Proud Boys row the previous year indicated some possibility of entertainment news? No matter, there wasn't much to see this year. Newt arrived fairly late. Walked slowly from car to the front door. We taunted him, did our best to embarrass him, but neither side took any bait, so he entered quietly.

## **Upcoming RAR Actions**

10/23, at 9:30 am, Wednesday. US 2nd Circuit Court of Appeals 40 Foley Square. Oral arguments will be presented at appellate level of Trump vs Vance case. The suit argues that State's subpoena of Trump's business & personal tax records is unconstitutional as President (and relevant associates) while in office are above the law and thus immune from prosecution or investigation; only solutions are post-presidency. It was rejected on the SDNY (first) level and is being fast tracked for immediate Supreme Court review. The constitution is unclear. Courts have been depending upon precedent, which affected Mueller conclusion in addition to cases such as this one. We will stand outside court with signs. Several will enter; they will roll open signage during a break. Perhaps 12-15 people raised hands that they will attend.

## Discussion: No new jails/Close Riders

Last week City Council passed the agreement to close the jail facility at Rikers Island by 12/2/21/2026. This is accompanied by a plan to build 4 new jails, nearer to the borough courts and to the families of those incarcerated. Causes concern. Is the City council plan linked with the plan to build the new jails? 9 billion has been put aside for programs for preventing criminal behavior in the first place. New capacity will be 3300. Now we have room for 12,000. Crime has consistently gone down so fewer beds needed. Also discussion of new uses for Rikers necessary. One idea is training in green jobs; there are others. Many questions. Are all jails new? For example, right now, the Bronx uses a barge: they will be among those getting a new jail. Brooklyn jail's cells are too small. Will they?

There will always be people who aren't offered bail, other reasons. What will the new jails size be? They have been determined. The new detention centers will be built to house around 3,300 total detainees and will hold 3,795 beds, down from the current jail population of around 7,200 and 14,000 beds across the system. Cost is another concern given the city's history of over-budget & over-time. John suggested this is bringing up many issues around incarceration. Perhaps we should form a group to follow incarceration.

Donna brought up how we vote. If more vote no or abstain but yes wins. What does it mean when there are a lot of abstentions? Claire - sometimes we vote when we have heard a presentation. Do we know all there is to know when we vote?

Donna pointed out there are differences in the sorts of issues we vote on. Jamie checked our by-laws. We need more than 50% abstentions; other than that, yay or nays win. Further discussion concerned our asking, "Are we ready to take a vote?", tabling the vote, and inviting another speaker with different, possibly even opposing viewpoints to come? This would permit us to look at issue before deciding to get on board. Although this has yet to happen with RAR, situations have existed in which people with agendas have come to meetings JUST because a vote is taking place.
